Beginning October 1, 2020, Nebraska law (Neb. Rev. Stat. §§ 28-1418 et seq.) provided the legal minimum age for use or purchase of tobacco products (including cigarettes, electronic nicotine delivery systems, and other tobacco products) will be 21 years of age.

Other items to look for when reviewing an ID.

Date of birth: Compare it to your Age-of-Purchase Calendar to ensure the customer is of legal age.

Photo: Compare the customer to the picture. Is this person the same?

Description: Does the description on the ID match the customer?

Expiration Date: All forms of identification used to verify age **MUST** be valid. Don't accept an expired ID!
